### Course Description

An intensive counseling field placement in a school counseling oriented setting under the direction of an approved on-site clinical supervisor as well as a member of the program faculty on campus. Students may repeat course until they have successfully accrued internship hours necessary to meet course requirements. May be repeated for up to a total of 12 semester hours.

## Internship Requirements (CACREP 2016 Standards 3.J;K;L;M)

The program requires completion of a supervised internship in the student's designated program area of 300 clock hours per internship section completed (for a total of at least 600 hours), begun after successful completion of the practicum. Each student's internship includes all of the following:

1. At least 120 clock hours of direct service per internship section completed (for a total of at least 240 direct hours), including experience leading groups
2. Weekly interaction that averages one hour per week of individual and/or triadic

counseling, small groups, and classroom guidance). Indirect hours are all other hours spent on site including but not limited to: consultation, non-assessment observation, planning, arranging, coordinating programs and services, reviewing files, organizing, etc. Further, weekly completed logs will be brought to class and periodically checked in class. At the end of the term, all logs and cover sheet should be submitted via email to Heidi Waters and your course instructor. Hours logs template can be found on Canvas. **NOTE: Completion of all hours is a necessary yet insufficient requirement for passing internship.**

3. **Summary Log and Evaluation Forms:** A summary Hours Log signed by the student, site supervisor and university supervisor along with midterm and final evaluation forms must be submitted. Evaluation form can be found on Canvas.

4. **Case presentations:** Each student will be required to present cases during supervision

## Credit Hour Policy Statement

In accordance with federal policy, NKU defines a credit hour as the amount of work represented in the achievement of student learning outcomes (verified by evidence of student achievement) that reasonably approximates one hour (50 minutes) of classroom instruction and a minimum of two hours of out-of-class student work. For every course credit hour, a typical student should expect to spend at least three hours per week of concentrated attention on course-related work including, but not limited to, class meeting time, reading, reviewing, organizing notes, studying and completing assignments.
